Capacity Lease Deal extends Connectivity Services on Viasat's Best Available Network

London, **[June 25, 2018].** Avanti Communications (AVN) has signed a \$10 million contract with global communications company, Viasat Inc. (NASDAQ: VSAT). The deal provides Viasat with leased capacity on a steerable beam on the newly launched Avanti HYLAS 4 satellite. The contract has an initial period of two years.
