ViaSat Adds Frank Biondi to Board of Directors

CARLSBAD, Calif., April 8, 2015 /PRNewswire/ -- <u>ViaSat, Inc.</u> (NASDAQ: VSAT), an innovator in broadband and communication technologies and services, today announced the appointment of Frank J. Mr. Biondi holds a bachelor degree in psychology from Princeton University, and a master's degree in business administration from the Harvard Business School.
