- The original restricted stock unit grant was for 4,000 restricted stock units on 11/10/2010. Subject to the reporting person's continued employment with the Issuer, the units vested and converts into shares of common stock (on a 1 for 1 basis) in four equal annual installments beginning on 11/10/2011.
- The original restricted stock unit grant was for 4,000 restricted stock units on 11/10/2011. Subject to the reporting person's continued employment with the Issuer, the units vested and converts into shares of common stock (on a 1 for 1 basis) in four equal annual installments beginning on 11/10/2012.
