- Subject to the reporting person's continued services as a Director of the the Issuer, the units vest and convert into shares of common stock of the Issuer at a rate of 1/3 on the first anniversary of the grant date; 1/3 on the second anniversary of the grant date and 1/3 on the third anniversary of the grant date.
- Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of the directorship with the Issuer.
- Each restricted stock unit represents a contingent right to receive one share of ViaSat, Inc. common stock.
