Subject to the reporting person's continued services as a Director of the Issuer, the units will vest and convert into shares of common stock of the Issuer at a rate of 1/3 on the first anniversary of the grant date; 1/3 on the second anniversary of the grant date and 1/3 on the third anniversary of the grant date.
- 4. Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of the directorship with the Issuer.
