The reporting person elected to defer the receipt of the shares of common stock for a period of ten (10) years. As a result of the deferral, the reporting person will receive shares of common stock as follows: 3,000 shares on 06/28/2019; 3,000 shares on 05/28/2020; 3,000 shares on 05/28/2021 and 3,000 shares on 05/28/2022.
- Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the Issuer.
