- Subject to the reporting person's election to defer the receipt of common stock, the units vest and convert into shares of common stock of the issuer at the rate of 1/4th on the 13th month anniversary of the grant date; 1/4th on the second anniversary of the grant date; 1/4th on the third anniversary of the grant date and 1/4th on the fourth anniversary of the grant date.
- Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment with the issuer.
